The realities are different - replacing the system of wars by replacing them with the means and methods of the Cold War, the next Second Cold War - with the creation of terrorism and the fight against it - terrorism, another kind of enemy - the creation of radical Islam and the subsequent fight against radical Islam.

with the ability to destroy the other (is every other) - a state of affairs that would be called mutually assured destruction - MAD.

This is the doctrine of mutually guaranteed destruction. And under this doctrine there is an increase in military budgets, spending of excess public resources on military equipment, on sabotage, on waging war outside the country - the United States.

5. A brief historical overview

The onset of the Cold War is usually associated with Churchill's March 5, 1946 speech at the university in the US city of Fulton. In Truman's play, the former Prime Minister of the United Kingdom calls the West only against the Soviet threat.

The first British publicist and writer George Orwell used the name "Cold War" in his essay "You and the Atomic Bomb" published on October 19, 1946, in Tribune magazine. The introduction of this notion into political rhetoric is attributed to the American financier and politician Bernard Baruch during his speech on April 16, 1947, of the Truman doctrine discussed: "Let's not go crazy - today we are in a state of cold war." The journalist Walter Lipman then published the 1947 Cold War book. On March 12, 1947, US President Harry Truman Asks Congress for Military and Economic Assistance Greece and Turkey Truman wants \$ 400 million and Congress agrees. Truman follows a policy of restraining communism. Truman's doctrines and the Marshall Plan foment this policy. October 1944 the conference in Moscow - divides the influence of the USSR in Eastern Europe - Russian influence in Romania is described by Churchill at 90%, in Bulgarians and Hungary - 80%, in Yugoslavia - 50%, in Greece - 10%. The British take control of the Greeks. February 24, 1945 - The Dulles Doctrine. In fact, about 100 days remain until the surrender of the German Reich. Speech by Alan Dulles, CIA Chief: "It will end the war".

August 1945 the two Atomic Bombs over Hiroshima and Nagasaki. Japan surrenders immediately. On August 29, 1949, The Soviet Union has had a successful nuclear weapons experience. Unlike the traditional conflicts and wars, the presence of atomic weapons in the hands of both adversaries opens up a new possibility for a special kind of war that can be waged without the use of that atomic weapon. The atomic bomb can be used indirectly - as a serious threat to the enemy. The atomic bomb project has been around since 1942, and is known as the Manhattan Project with the participation of atomic physicist Robert Oppenheimer. The cost of the project is about \$ 2 billion. The Soviet nuclear program is known under the leadership of Igor Kurchatov. He made a promise in 1947, that he would build a Stalin atomic bomb. Kurchatov actually began exploring the atomic nucleus in 1932. Seven years later, under his leadership, the first Russian particle accelerator in the USSR came into action, and he soon reached the discovery of the decay of the uranium atomic nuclei. The first nuclear reactor came into force on December 30, 1947. Igor Kurchatov created both the first atomic bomb of the USSR and the first thermonuclear / hydrogen / bomb in 1953.

The United States created the atomic bomb and immediately began developing plans for an attack on the USSR. May 19, 1945 Operation "Unthinkable" - Unthinkable Churchill enslaves operatives to war with the USSR - with the start of military action planned on July 1, 1945 - participants in 47 Anglo-American divisions, incl. 14 brigades, plus 10-12 German divisions, direction - Poland, the goal is to push the USSR out of Europe. The operation fails - the plan was revealed by the famous Cambridge Five, which was transmitted to the USSR - Kim Philby, Anthony Blunt, Guy Burgess, Donald MacLean and John Cairncross.

August 1945 - Operation Totality - President Truman and in conjunction with the leadership of Gen. Eisenhower - Future President The United States is developing an operation for an atomic war against the USSR. The plan is - nuclear bombers with 20-30 nuclear bombs., Destruction targets - Moscow, Gorky, Kuibyshev, Sverdlovsk, Novosibirsk, Omsk, Saratov, Kazan, Leningrad, Baku Tashkent, Chelyabinsk, Nizhny Tagil, Magnitogorsk,

Magnitogorsk, Grozny, Irkutsk, Yaroslavl. At the moment, the United States does not have a nuclear bomb and the two that are available are thrown over Hiroshima and Nagasaki. It's a blunder, bluff..

In 1946 - 1948, the United States developed a series of ram plans against the USSR, such as: -1946 - Pincher, 1947 - Broiler, 148 - Bushwhacker, KKrankschaft, Fleetwood, Kogvill, Offtackle, Charioteer, Shakedown, 1949 - Dropshop, Trojan. These plans include massive nuclear bombings over the USSR with a minimum of 200 atomic bombs, the destruction of strategic cities, and of the entire industry. August 18, 1948 - US National Security Council Directive - The government is forced to set much clearer and more militant goals against Russia.

For example, under the Chariotir plan, the attack period of April 1, 1949 they planned to launch 133 atomic bombs over 70 Soviet cities in 30 days, followed by another 200 bombs. Under the Dropshoot plan, they plan to launch an attack on 01.01.1957. Initially, the launch of 300 bombs in the second stage is planned for the launch of 250 divisions and the occupation of the USSR. And only the test by the USSR of the superpowered 58 megaton hydrogen bomb - the thundering October 1961. has moderated American strategies.

The amount of spending on USSR defense in GDP. Post-World War II Situation - "The Soviet Union is the weaker partner on the other hand. The Soviet Union is weakened by the war, but possesses vast resources and a high level of industrialization under Stalin's rule. The Soviet Union left the Allied Control Board after three of the Great Powers prepared for the introduction of the German mark in the occupied zones on June 16, 1948. This is really the day when the Cold War gets a specific choice and image. A day later, the Soviet Union blocked all the dry and waterways to West Berlin. On June 24, 1948, the blockade of West Berlin began. The two super powers don't really want to risk and destroy each other. However, they create conditions for conflicts in which they do not directly confront each other. These are Korea Vietnam, Cuba. In reality, these conflicts are replacing direct military confrontation. Competition continues in space. In October 1957. The Soviet Union launches the first satellite in the shaved Sputnik. For three years, the Soviet Union sends the first man to space, astronaut Yuri Gagarin. US President Eisenhower is worried. There is a real start to the arms and space race. Cold ostrich sharpened as in 1961. The GDR builds the Berlin wall. In Vietnam, the Soviet Union supports Vietnam. In 1980. NATO decides to deploy Pershing-2 missiles in Germany.

6. Cold War Principles- When the conflict between the US and the USSR demands the two parties begin to negotiate

The two-pole system is actually predictable. The US is a superpower. In reality, there was cooperation between the two countries, the USSR and the US, in military production during the so-called Cold War. In 1929, the only fully manufactured aircraft in Russia is the 3-kopecks of the British. 1932 - 1940 - More than 20 US companies supply aircraft and spare parts to the Soviet Union.

In 1938, The USSR purchased a license from the US government for the alias of the DS-3, and later transformed it into RS-84 later Lisunov - Li-2, the best Russian transport aircraft. 1932 all the USSRs are imported from abroad and the t-27 was manufactured in a factory in Leningrad and represents the British Mark - 4 Stalin admits that 2/3 of the entire Soviet industry was built with US involvement. Each automotive industry in one country is a key contributor to the development of armaments / planes, ships, trucks and armored vehicles. Some of the largest US companies .. page 89 have had their offices in Russian factories. The Gorky Soviet automobile fair was built by Ford in 1932, in 1946. the British government gives the USSR 55 turbojets, of which 25 were manufactured... and the remaining 30. Towards the end of the 1960s, the Italian company FIAT signed an agreement with Rockefeller's Chase Manhattan Bank to build a plant in Toliati's Russian core. Three-quarters of the equipment of the new plant were shipped directly from the United States. Both sides have similar characteristics - the same

production technology. There is military cooperation between the US and the USSR. 1964 The US exports US military technology to the USSR.
