**Prof. Momtchil Dobrev-Halachev's Mafiotismus in USA -
import, creation, management and support of the mafia in
Bulgaria with prime –minister Boiko Borrisov by the
presidents of the USA Mr. Barak Obama
And Mr. Donald Trump**

Abstract

In 2010, Lord Prof PhD Momtchil Dobrev-Halachev developed "Financially banking resource-based technological mafia-driven materialism" as a principle based materialism since more than 17 centuries and created in 2010 "The Theory and Praxice of Mafiotismus" and in 2001 "The Theory of the mafia". Based on these theories, this paper provides evidence of how the United States practices mafia by importing, creating, and managing mafia in the country of Bulgaria. The article provides incontrovertible evidence of the country's mafia, the court and the prosecutor's office, which the mafia backs with the inauspiciousness of President Obama and US President-elect Donald Trump.

1. Introduction

In the year 2010, Momtchil Dobrev developed the "Theory of Mafiotismus" as a new state level based on the private and personal interests of prime ministers, ministers, government. And when US presidents say they will fight, and their ambassadors to Bulgaria declare their desire and purpose to fight corruption in Bulgaria, and on the other hand, after informing them about the extent of corruption and the mafia in Bulgaria, it proves that in reality the US has no intentions to tackle or support the fight against corruption and the mafia in Bulgaria, as Prime Minister Boyko Borisov's politicians are conducive to the wishes, goals, aspirations of the United States in all its directions and to the fight against Russia's main enemy me. The article reveals the real nature of the US and its interests in Bulgaria.

Disclosure of the true intentions of the United States regarding the custody and guardianship of Bulgaria is important to uncover the truth.

was appointed with the approval and under the direct control and management of the former US Ambassador to Bulgaria.

This also happened in 2019 after then Chief Prosecutor Sotir Tsatsarov took to the United States Deputy. The Prosecutor General of the Prosecutor's Office Ivan Geshev. He was also the sole candidate for the Attorney General and was accordingly selected by the Supreme Judicial Council on proven false statistics and documents in connection with his activity as a prosecutor for decades.

The Mafia System in the Judiciary

The Supreme Judicial Council, as an institution which is to supervise the actions and conduct, and acts of judges and prosecutors, take no action, on the contrary, they support such lawlessness.

Private enforcement is governed by the Mafia. They commit crimes, the prosecutor's office supports and maintains them, and strays an umbrella over their crimes. The prosecutor's office legitimizes, through its inaction and acts, crimes committed by prime ministers, ministers, statesmen, judges, prosecutors, people and businesses of the mafia. Prosecutors and judges receive scholarships for specialization in the US, although US law has nothing to do with Bulgarian law. The Mafia appoints and manages the presidents of courts in Bulgaria. Judges from the Supreme Administrative Court and administrative courts legalize crimes committed by ministers, ministers, statesmen, state institutions, ministries. The judges from the administrative courts legalize racketeering, thefts, the iniquity of the institutions of the executive branch. Ie A DEAD LOOK at the people who claim their rights.

Including proves for ownership of Goldman Management to the state company BULGARIAN POST JSC. Based on the Dept.

4.1.1. Timeline of the case "Bulgarian Post" and ownership of the company BULGARIAN POST JSC. from the American company "Goldman Management".

4.1.2. The earned by Goldman Management dept from "Bulgarian Post" JSC. To other third party contract from 17 of December 1998. The DEBT is with daily capitalization interest of 3 percent in a day.

4.1.3. Protocol of the secision in 25 of September 2006 in trade case 1456/2006 in Sofia City Court. Taken expertise for the dept from the company “Bulgarian Post” to the American company Goldman Management about 350 Bil. USD. This case is since 2006 missing in all the Bulgaria and in the justice system in Bulgaria. The MAFIA of the government is the order.

4.1.4. Request for answering to prime minister Boiko Borrissov 04 of July 2011.

Many times the main prosecutor Sotir Tzatzarov, the new main prosecutor since Devcember 2019 Ivan Geshev, the prime minister Boiko Borissov are informed like the last forth invitation to the prime minister Boiko Borissov from 20 of November 2019 to execute the law regarding this men R. P. No activities from these people and all the state and state institutions.

4.5.2. Proofs How Sofia City Court Judges such magistrate Vl. Valkov, ordanova, Boicheva, R. Martinova, Al. Angelov from Sofia City Court Legalize Property Thefts, Equipment for Millions, Factories, Whole Properties, Houses in Downtown Sofia - Loses \$900 Million.

4.5.3. Proofs How Krassimir Vlachov Former Deputy Chairman of the Supreme Court of Cassation since 2013 has never won a competition to be a judge in the Supreme Court of Cassation and has ruled and wrote judgments for 13 years illegally. - lost \$970 million. He put magistrate based on his resolution to solve cases without using the software for случаен choice of magistrates. He is now constitutional magistrate as a present of the mafia for his activities.

4.5.4. Proofs including this letter How Judges from Sofia City Court, Vladimir Valkov, Raina Martinova, Albena Boteva, Lyubka Golakova, Alexander Angelov, Svilen Stanchev, Elitsa Yordanova, Kutskova, Kozhaliyeva, Eric Vasilev, Tsacheva, Tsonev, and dozens of others legalize theft of equipment, factories, factories private individuals for the benefit of the Mafia people. lost for \$1 billion. Including sixth invitation to prime –minister Boiko Borissov to execute the law– from 20 of November 2019.

4.5.5. Proofs including How judges from the Supreme Court of Cassation commit crimes by legalizing the crimes of the Boyko Borisov Council of Ministers has lost \$5 billion.

4.5.6. How Private enforcement agents fs Stoyan Yakimov and Alexander Dachev - Mafia Affiliates and Prime Minister Boyko Borisov Commit Criminal Offenses for Mafia Loss US \$ 9 Million for US Company.

4.5.7. How private enforcement agents Stoyan Yakimov and Maria Tsacheva conduct business with their own companies run by their relatives in violation of the law - protection again by Boyko Borisov and Tsatsarov, who does not initiate criminal proceedings. Including presentation for payment for American company from 12 of March 2019 and forth invitation from 20 of November 2019. Including Invitation for payment to Prime minister Boiko Borissov from 20 of November 2019 - 2 times for Loses of 5 BILLIN USD for investments and loses for 75 Mill Euro for theft of land from private lends. No activity neither from President Obama neither pf President Donald Trump.

4.6. Result 7 / seven/ attempts for killing Prof. Momtchil Dobrev, no investigations from the state institutions. Other proofs given to the President Obama and President Dnald Trump for the mafia in the ulgaria, the mafia in the justice system in Bulgaria, mafia in the state institutions, mafia in the government.

5. Mafia in the country with Prime Minister Boyko Borisov, notified by the US President and supported by the US and its presidents and administration

5.1. There is undisputed evidence that judges from the Supreme Court of Cassation - Tanya Raykovska, Dariya Prodanov, Totka Kalcheva, Nikola Hitrov, Eleonora Chanacheva, Emil Markov from the Supreme Court of Cassation - Judges from Glozhenska, Bozhikov, Spasov from the Court of Appeal of the European Court of Justice deliberate breach of binding directive 2008/6 / EU of the European Union and the European Commission of 01.01.2010. according to which since 01.01.2011. the state-owned company Bulgarian Posts-EAD has no monopoly on its activities, and the same monopoly was abolished as of January 1, 2011. and they are, in fact, the cause of particularly large losses by executing an executive order.

The same judges allowed themselves under case 519/2012 of the Supreme Court of Cassation, under part-case 798/2011, part-case case 689/2011, to the Court of Appeal Plovdiv, part-time. 3765/2013 to confirm the termination of the bankruptcy case of Bulgarian Post-EAD for its debt of more than 50 000 000 000 / fifty billion / euro, and in fact, in addition to breaking the laws and causing the above huge loss, performed only and only to benefit of the state Mafia, to benefit ministers 'crimes, Prime Ministers Stanishev, Boyko Borisov. The judges of the supreme court of Cassation have ruled a declaration concluding a violation of the law, as of 01.01.2011. the state-owned company BULGARIAN POSTS -EAD has no monopoly on its activity, and the same monopoly was abolished as of January 01, 2011. Under the directive of the european union, which is obliged to obtain from 01.01.2010. the bulgarian mail company-EAD has been dismissed. This directive is binding on all Bulgarian judges.

5.2. Many times Boyko Borisov was informed that Minister Moskovski does not comply with the laws of these states and the statutes of Bulgarian Mails - EAD as his principal.

Attached to the Prime Minister Boyko Borisov, Moscow and these Ministers of Transport, adopted conclusion - Expertise of an expert in commercial case 1456/2006 of the Sofia City Court on the merits of the company Goldman Management LLC to the state company Bulgarian Posts - EAD - accepted Opinion in Commercial

Case 1456/2005 of the Sofia City Court with the plaintiff Goldman Management-OOD and the defendant Bulgarian Posts-EAD for the obligation as of 20.06.2005. amounting to 36 digits.

Requests to the Prime Minister BOYKO BORISOV dated 09.07.2010. No. 32-02-2453.

Requests to the Prime Minister PLAMEN ORESHARSKI entr. № 11-00-393 / 12.08.2013r.

Request to the Prime Minister SERGEY STANISHEV dated 22.05.2009. and dozens of others to you personally.

Considerations for Boyko Borisov date 29.03.2016. There was no reaction by any Minister President Boyko Borisov.

5.3. Presidents Barack Obama and Donald Trump have been subject to a violation of any law by the Council of Ministers as Prime Minister Boyko Borisov for the Council of Ministers' Decision No 43 of 23.01.2009, Decision No 69 of 15.02.2010 has entered into an unlawfully made concession on Property Private Property - Private Land - additional to a concession area of 2 928.5 in the amount of additional area of 9 084 decares Private Property, with the sole purpose of stealing this land.

There have been repeated requests to the Council of Ministers with the Minister of the Interior, Boyko Borisov, Stanishev, to terminate this Illegal Concession. Until now, there has been no enforcement of the laws of the Republic of Bulgaria by the Council of Ministers of the Republic of Bulgaria with Prime Minister Boyko Borisov.

5.4. Deaths for Death by e-mail - from Germany and quoting the Praker of a Visible Bulgarian State in Deaths for Death by Lord Prof. Dr. Momchil Dobrev Dobrev and his entire family - manager of companies. There is also a real refusal by the German Government with Chancellor Ms Merkel to investigate the Threats about death by e-mail sent by Germany.

5.5. Seven attempted murder of Lord Prof. Dr Momchil Dobrev Refusal of Police and the State in the Face Prosecution of Managed by Prosecutor Sotir Tsatsarov - to carry Even Checks for attempted murder and even require records of attempts about kills at Sofia Downtown.

5.6. Prime Minister Boyko Borisov has been repeatedly invited to halt the construction of the North Tangenta around the city of Sofia since March 2015. to March 2016 1 950 000 cubic meters of Land from private land has been stolen from private companies. Neither the Prime Minister Boyko Borisov, nor the institutions of the Mayor Fandakova of the City of Sofia, the State Financial Library, Rios Sofia, Dnsc Sofia have taken any measures. Loss for over €76 million.

6. The Mafia in the Judiciary in Bulgaria, notified to the President of the United States, and supported by the United States and its Presidents and Administration

The wrong doing and iniquity of judges by the Sofia City Court, the Sofia District Court, the Sofia Court of Appeal, the Supreme Court of Cassation, Burgas District Court, Burgas Court of Appeal - dismissal of cases, disappeared cases. There is an order from the Mafia in the judicial system for certain persons and companies to lose cases against banking, insurance companies, metropolitan municipality, ministries.

This is confirmed by the actions of the presidents of the Sofia City Court Kaloyan Topalov, LAeksey Rifonov, the chairman of the Sofia Court of Appeal Daniela Doncheva, the chairman of the Supreme Court of Cassation Lozan Panov, the chairman of the Supreme Administrative Court Gov. Lalov District Court and other courts.

Although the judges weave Vladimir Valkov, Albena Boteva, and other judges dismissed dozens of cases in cases in which they were ordered to lose a company or person, even though they have been dismissed in the cases of these companies or physically persons, these judges have to dismiss themselves and execute the

Mafia's order to make decisions that legalize theft of property, theft of equipment for millions, theft of property for hundreds of millions of euros.

Despite lawsuits filed against such judges as Valkov Boteva, Raina Martinova, Aleksander Angelov, Stanchev, and dozens of others, and despite the mandatory instruction of a member of the Code of Civil Procedure to dismiss their respective cases, they do not, and on the contrary, legalize the theft of property, equipment and no chairman such as the courts Alexei Rifonov, Doncheva of the Sofia Court of Appeal, Lozan Panov of the Supreme Court of Cassation do not undertake or fulfill their legal obligations to resign these judges.

This order of the Mafia is confirmed to be similar to the gene Luben Gotsev, who in 2005. spoke to Prof. Momchil Dobrev: "This Cannot Ride it Ever !!!", and was ordered by the Mafia to lose all cases. Judges such as Alexander Angelov, Ladimir Valkov, Raina Martinova, Yordanova, Boncheva do not execute enforceable court decisions and rule on the contrary resolved in favor of the theft of property and equipment. Mafia orders disappear in courts, court cases disappear, appeals disappear. At the time of Judge Georgi Kolev was chairman of the Sofia City Court, claims for tens of millions of BGN in the case of the Sofia City Court bankruptcy case of Kremikovtsi 95/2007 disappeared. Decisions with won cases in the CPC disappear for tens of thousands of euros against debtors, for real estate and others, which have disappeared until the moment 2020. Don't know where any chamber, no session.

The fact that at the judge's property then Yordanka Mollova and her brother Hristo Mallowov found the State Gambling Commission 2006 My Games and Binging Equipment and caused losses of over 10 million leva - which is a real "breach" by the KAAEC. Because hundreds of cases filed by people fighting the Mafia in court, cases against debtors over 390 cases in Sofia District Court, Sofia City Court have disappeared. The order of the Mafia was fulfilled when 2006 was completed. Mafia people with the assistance of judges of the hcv stole a factory for 35 million in which a factory a company owns 49% of the shares paid to the million leva stock exchange. It lost more than € 300,000 a month from that factory. It is confirmed that in a case in the CAS for hundreds of millions of US company against the Metropolitan Municipality on the order of a statesman - a criminal - proven by the services of the US State Department and others, it ordered judges to lose the case for \$ 102 million.

The Mafia in the court also fulfills such orders when cases of former owners of DZI's buildings are brought - on Tsar Osvoboditel Blvd. with a total built-up area of more than 15,000 square meters, a property in the center of Sofia. , Positano building - four floors, Maria Louisa Blvd building - 6 floors - transferred by the Mafia - Sofia Court of Appeal of Kyustendil District Court, Blagoevgrad District Court, OS Vrata, Vratsa as all judges from those courts have been given out - these judges in performance of the order of the mafia is discontinuing actions in 2007 for real property over 500 million euro - The Theft of Our Properties by Emil Kyulev - For Zero Fines through Notary Rumen Dimitrov. The Mafia Order has been in operation since 2005. when Judge Tsenov receives the order, the mafia will bring a perfectly healthy person into the madhouse on the order of a mafia judge so that the judge Malls can acquire all the companies and assets, and against the promise of a judge from the SCC that he will raise him Judge and against the promise of one judge of the SCC, that he will raise Cenov as judge in the SCC because of his decades of experience as a judge.

Evidence of the order fulfilled is confirmed by undisclaimed factology: Mafia's order to the National Revenue Agency to seek 48 million "unpaid" Taxes from individuals who refused to transfer and donate mini-properties. - Chairman. After all, these people's revisions prove that they don't owe a penny.

Supreme Administrative Court Number 12717.

7.6. Objects signal - request for education immediately of disciplinary cases against violations committed by judges with entry number in the Supreme Court of Cassation - 8259 dated 16.07.2015, SJC - entry number 94-00-903, entry. Number in the Inspectorate of the SJC 503 / July 16, 2015. The actions were performed by judge Evgen Georgiev. Loss for over 5 billion Euros.

7.7. Objects of complaint application dated 24.08.2015 to the Supreme Judicial Councils and to the Inspectorate ent. Number 94-00-1015 and entry number in the inspectorate at SJC 1256 / 24.08.2015. for criminal offenses from judges from the sofia city court caused and loss above 16 000 000 / levs and losses of 5 billion euros currency under Article 95/2007.

7.8. Complaints of appeal from 01.09.2015 against the refusal of the supreme court council, by reference number 94-00-618 / dated 23.06.2015 give them to give a check and propose for immediately dismissal everything above provides that there is a mafia in the judicial system. infringement of the laws of the republic of bulgaria, use of official purposes aimed to cause huge losses €.

7.9. Despite unquestioned evidence of Judge Rayna Martinova's arbitrariness by Sofia City Court causes guaranteed losses for over € 350,000 - Supreme Judicial Council Dismisses her.

7.10. Despite the incontrovertible evidence of the arbitrariness of Judge Albena Boteva from the Sofia City Court causing a guaranteed loss for millions of euros, the High Court Council did not dismiss her. She is from the Mafia. The High Court Council hides crimes committed by judges and prosecutors.

8. Mafia in the Supreme Administrative Court, notified to the President of the United States, and supported by the United States and its Presidents and Administration

8.1. Judges of the Supreme Administrative Court of Adm. Case 4696/2014 and Adm. Case 7776/2018 instead of terminating an illegal concession given on 04.06.2010. by the Council of Ministers with Prime Minister Boyko Borisov - private land of the Celsian Concessionaire have written that this land is municipal property, although it is proved that the land from 2008 is a Private Property owned by the companies Goldman OOD and Goldberg Group OOD. Lose \$ 5 billion - failed investment.

8.2. The judges of the Supreme Administrative Court and the Administrative Court of Sofia city support the Mafia of Sofia Municipality and the Municipalities of Sofia Municipality in the determined - witness - not law of property tax assessments. It lost over 120 million euros.

8.3. Judges from the Supreme Administrative Court and the Administrative Court Sofia city support the lawlessness of the Minister of Justice, Tsetska Tsacheva, who refuses to comply with the law and issue an order to inspect the PEA's Georgi Dichev in appropriating notes of it for millions of dollars.

8.4. Judges from the Supreme Administrative Court and the Administrative Court Sofia City uphold the lawlessness of Justice Minister Tsetska Tsacheva, who refuses to comply with the law and issue an order to inspect the PEA's Stoyan Yakimov's decree in embezzling millions of money.

9. The Mafia in the Justice Department, who was notified personally by President Barack Obama and President Donald Trump

The Mafia in the Ministry of Justice under Minister Tsetska Tsacheva - appointed by Prime Minister Boyko Borisov.

9.1. On 30.08.2018. The evidence of Minister Tsetska Tsacheva was attached to the Ministry of Justice - Minister of the Government of Prime Minister Boyko Borisov of the Gerb Party to implement the Private Enforcement Agents Act Art. 31 para. 1 item 5 in connection with Art. 6 para 1 item 7 And to issue an Order for the termination of the rights of Private Bailiff Stoyan Blagoev Yakimov as a private enforcement agent due to his commercial activity with the companies with the manager his wife Eco Bio Agriculture, Enelyushans, Boyana Estates 2013, Nonda. Until the moment Minister Tsacheva December 10, 2018 does not comply with the law. Because Pea Stoyan Yakimov is from the Mafia and with protection from GERB and Prime Minister Boyko Borisov.

9.2. On 09/21/2018 Evidence from Minister Tsetska Tsacheva - Minister in the Ministry of Justice in the Government of Prime Minister Boyko Borisov from the GERB Party was submitted with a request to implement the PEA Art. 31 para. 1 item 5 in connection with Art. 6 para 1 item 7 And to issue an Order for the termination of the rights of Private Bailiff: Maria Krasinova Tsacheva and Private Enforcement Agents Vladimir Lyudmilov Tsachev as private enforcement agents because of their commercial activity with the company in which they are shareholders and which company has in its capital dozens of Oktogor Blastic properties. Until the moment Minister Tsacheva December 2018 does not comply with the law. Because Private Enforcement Agents Maria Tsacheva and Private Enforcement Agents Vladimir Tsachev are from the Mafia and with the protection of GERB and Prime Minister Boyko Borisov.

9.3. For more than two years, Minister Tsetska Tsacheva, Minister of Justice, has refused to inspect and initiate disciplinary proceedings against PEA Georgi Suikov Dichev for appropriation of more than 950,000 euros since 2008. according to the case, proven by the prosecutor's office and a real crime under the Criminal Code and its deprivation of rights, there is no reaction of Minister Tsetska Tsacheva to initiate an inspection and deprive the PEA Georgi Dichev - because the same is a mafia of the mafia Sotir Tsatsarov, B. Borisov

personally and from the GERB party. An umbrella was stretched by her and Inspector Grigor Todorov from the Ministry of Justice. Because he's from the Mafia and he's a TOP Mafioso. Loss too 2 500 000 euros.

9.4. For more than two years now, despite the enclosed evidence of Minister Tsetska Tsachev - Minister of Justice, that Private Enforcement Agents Stoyan Yakimov has committed an appropriation of huge amounts of money - ie. committed epoch penal code in dozens of enforcement cases, there is no reaction of Minister Tsetska Tsacheva to initiate an inspection and deprive PEA Stoyan Yakimov - because the same is from the Mafia - his father from the State Security Services and supports Bafia. and from the GERB party. He lost over 2,500,000 euros.

9.5. On 15.11.2018 Minister to Tsacheva was applied for immediately issue the inspection order and then disciplinary proceedings by decision Deprivation forever PEA Stoyan Blagoev Yakimov as part bailiff despite being mafia and direktono supported by Mafia of GERB by Dim Dobrev Consulting House Ltd. with evidence of gross misconduct - extraordinary delay a consciously made by Csi Stoyan Yakimov for the benefit of the Mafiota Group and Mafia Group and by eight months - delay in the administration of the complaint and as a result of the loss of the property for which we were declared as a buyer by PEA Stoyan Yakimov in Execution Case No. 20168440400240. The loss is over EUR 4.9 million.

9.6. On 11.15.2018 Minister Tsetska Tsacheva has applied for immediately issue the inspection order and then disciplinary proceedings by decision Deprivation forever PEA Alexander Dachev as part bailiff despite being mafia and support directly from a predzsedatelya Chamber of PEA Georgi Syikov Dichev from invest Md Trader Ltd. with evidence of court violations - Failure to take into account a claimant and remove a real creditor in public product scientifically made by the PEA Aleksander Dachev in favor of a company and the Mafia Group Mafia team and its company.

9.7. Minister Tsetska Tsacheva - Minister of Justice, has repeatedly been requested to fulfill her obligations under Art. 312 of the Judiciary Act and to request from the Supreme Judicial Council the immediate dismissal of one of the following judges: Albena Boteva, Raina Martinova, Vladimir Valkov, Evgeni Georgiev, Svetlin Mihailov, Alexander Angelov, Kaloyan Topalov and Sofiyotni Grad Andonova-Parashkevova, Parashkevov, Simeon Mihov, Hadzhiev, from Burgas District Court, Judges Zlatina Ivanova, Romyana Mankova, Svetla Tsolova from Burgas Court of Appeal, Judges Daniela Doncheva, Asya Sabeva, Atanas Kemev, Ivo Yaetou etrov, Galya Ivanova, Zornitsa Haydukova, Nelly Kutskova,, Boykinov, and dozens of friends from the Sofia Court of Appeal, Judges Krasimir Vlahov, Tsonev, Stoil Sotirov, and dozens of others from the Supreme Court of Cassation, Judges Kostadinen, Veslavadov, Bratalenadov, Bratal The District Court, the GSP Prosecutors, and the EWP for gross misconduct - non-compliance, deliberate enforcement of damages - loss of over hundreds of millions of judges, supporting the mafia in the judiciary. So far, Minister Tsetska Tsacheva has not fulfilled her duties as Minister. A Beautiful Umbrella. It lost over 800 million euros.

9.8. Minister Tsetska Tsacheva has been asked to institute disciplinary proceedings against Private Mafia bailiffs who have damaged the state budget by more than € 18 million, allowing theft of state-owned companies for millions of euros. So far, Tsetska Tsacheva has refused, together with Inspector Grigor Todorov, to refuse to form any disciplinary proceedings - Evidence of a manifest umbrella over crimes committed.

We have applied multiple requests to the Council of Ministers to terminate this Illegal Concession.

On 03.04.2013. was requested by the Prosecutor General Sotir Tsatsarov, appointed by the City Prosecutor of SOFIA Kokinov as Chief Prosecutor for the implementation of criminal proceedings against the people - extra ministers of the economy Tr. Trakov, minister Dilian Dobrev, Deputy Ministers Valentin Nikolov, deputy minister Haritonova, Miroslav Katsarov, and Prime Minister Boyko Borisov For an obvious and proven crime - giving Private Land on a concession - in violation of any laws. Caused loss - losses from investors and over 5,000,000,000 / five billion / US dollars.

10.2. Inactivities of the prosecutors, personally informed the Prosecutor General Sotir Tsatsarov and the new since main – prosecutor Van Geshev to investigate the omission of the Prime Minister Boyko Borisov for the theft of land from our own lands and construction with this ground mass of the Northern Tangent - a loss of over 76 million Euros. Although we have proved that under the European Program for the construction of the Northern Tangent of the city of Sofia, the executive itself Akali Private Land 1980000 cubic meters of Earth Mass and with Hey is built the "Northern Tangent" of Sofia, despite the signals to Prime Minister Boyko Borisov , to the Mayor of Sofia Fandakova, to various institutions, proof of the Prosecutors of Society of Tsatarov did not constitute criminal prosecution against the guilty. Loss over 76 million euros.

10.3. Inaction of the prosecutors and personally informed the chief prosecutor Sotir Tsatsarov for the lackluster of the Prime Minister Boyko Borisov and transport ministers in connection with the huge obligations of the State company "Bulgarian Post JSC. and failure to comply with the laws of that state. lost billions. Proofs are given to the main prosecutor Sotir Tsatsarov - proofs applied to Prime Minister Boyko Borisov, Minister Moskovski, Minister Tsvetkov and he did dozens of PROOFTS since 2010. because the transport ministers of Oyko Borissov do not comply with the laws of the Republic of Bulgaria - the Commerce Act, the Law on Obligations and Contracts in relation, the statute of the "Bulgarian Posts %- state company as Principal in connection with the obligation under art. 1456/2005 the company "Bulgarian Posts" – JSC. to the company "Goldman Management" LLC and the real non-fulfillment of Art. 295, Para 1 of the Commerce Act, Art. 2 of the Statute of "Bulgarian Posts" -EAD Art. 187E of Commercial Sack, Art. 130,131 and 132 of the Obligations and Contracts Act for the transfer of 95% of the shares of Bulgarian Posts Ltd. to Goldman Management LLC.

We applied to Prosecutor General Sotir Tsatsarov unmistakable evidence that judges of the Supreme Court of Cassation, Tanya Raikovska, Daria Prodanova, Totka Kalcheva, Nikola Hitrova, Eleonora Chanacheva, Emil Markov from the Supreme Court of Cassation - the judges from Glojenska, Bozhikov, Spasov from Plovdiv Court of Appeal grossly violate Bulgarian and European laws knowingly breaching a mandatory EU Directive 2008/6 / EU and the European Commission from 01.01.2010. according to which from 01.01.2011.

the state-owned company "Bulgarian Posts" -EAD does not have a monopoly on its activity, and the same monopoly has been revoked since 01 January 2011. and are actually causing very large losses, fulfilling an order of the executive. The same judges allowed the Supreme Court of Justice of the Supreme Court of Plovdiv, under item 798/2011, file no. 3765/2013 to confirm the termination of a case for bankruptcy of Bulgarian Posts - EAD for its obligation amounting to more than 100 000 000 000 / one hundred billion

10.4. Prime Minister Boyko Borisov's inaction and prosecutors and the Attorney General - personally informed about the participation of a MRDPW Minister in the sale of GUSV property at prices - 3-5 times below the tax assessment of third parties and participation of a MRDPW detective and government officials GASV in fraud and theft of property for millions and receiving millions against a debt of only BGN 249,000 and the fraudulent schemes of the person KAM The PEAs of GERB MAFIA have penalized the state with a ND of 18 million euros instead of translating them to the State Budget, the NRA, this money went into private pockets. The Prosecutors of the Prosecutor's Office Stanisca, Toncheva, Hristova, Kamenov and dozens of others refused to be criminalized and realistically criticized for the violations of the PEAs, which cost the budget more than EUR 18 million, was implemented through the PEA by the Mafia of the State Company for tens of millions of euros, is actually a stretched umbrella over the private enforcement agents, close to the government as well as private companies.

Prosecutor Hristo Tomov PER PR.PR. 1954/2005 of the Bulgarian Protection Agency in Veliko Tarnovo. Prosecutors Svilen Tsvetkov, Procurer Nikolay Iliev - PR.PR. 2953 / 2005D. Procurer Vicho Vichev - PR.PR. 52700/2005 – EWS, Procurator Hristoskov - SRP - PR.PR. 52700/2005, Procurer D. Evilova - PR.PR. 52700 / 2005D, Prosecutor Elmayan - Vacant pr.pr. 16332/2006, Prosecutor Mariana Stankova per pr.pr. 7108/2009, procurer B. Balev - pr.pr. 9223/2009. And to remove the breakdowns against them that happened chair over Yordanka Mollova and her brother. Losses about 29 million EURO.

10.6. The inaction of 2009 by the Prosecutors of the Sofia prosecutor office and personally prosecutor general Stir Tsatsarov for actions against a Private enforcement agent Mr. Georgi Dichev for assigning over 950,000 Euros in 2008. Proceedings from the Dochev Prosecutor. There is no reaction and action for the initiation of a criminal case against PEA Dichev - since it is from mafia and is used by the protection directly to the chief prosecutor Sotir Tsatsarov. Loses of over 2 Mil. Euros.

10.7. The inaction of 2009 by the Prosecutors of the Sofia prosecutor office and personally informed the prosecutor general Sotir Tsatsarov for supporting actions - assignment and use of official position by Private enforcement agent Stoyan Yakimov - on dozens of enforcement cases - Additional Dependent Chair of Prosecutor General Sotir Tsatsarov and the new main prosecutor Ivan Geshev over PEA Stoyan Yakimov . Loses of 2,5 Miliion Euros.

10.8. The inaction of a prosecutor and Prosecutor general Sotir Tsatsarov to prosecute stolen zero-dollar theft for over 500 million euros on the basis of a zero-stotinki note. Acts of Emil Kyulev from notaries R. Dimitrov and Sie, and theft of property the heirs of insurance companies - a theft of property in the center of Sophia for 500 million euros. Despite dozens of signals of the illegal actions of the Mayor of Sofia 2007 and the lackluster of mayor Fandakova, who does not want and does not want to execute a judicial decision of the Supreme Administrative Court, according to which the below mentioned properties are owned by the heirs of the former insurance companies before 1944. "Farmer," Balkan ", "Balkan Life "and others in the center of Sophia, 1 Pozitano Str., Sveta Sofiya Str., 6, Tsar Osvoboditel Blvd. - a building with a total area over 11 500 sq.m. , Maria Luiza Blvd. 75 - 77, Bergalnitsa 39 and dozens of other properties., and real hammm fandakova disclaims to incurring your own property property, and remains these repairs and declares the public sale of these properties and wants to sell them to third parties - although the decision of the supreme administrative court Even Mayor Fandakova has, righted a municipal notarial act of property not owned by the Sofia Municipality Loses of over 800 Million Euros.

10.9. The inaction of prosecutors from the Sofia city prosecutor office and personally notified prosecutor general Sotir Tsatsarov for a missing case in the bankruptcy case of Kremkovci JSC. for EUR 14 million of a secured creditor and losses of more than EUR 14 million.

10.10. The inaction of prosecutors and personally informed prosecutor general Sotir Tsatsarov about our disappeared cases over 390 cases in Sofia City Court and in Sofia District Court - won at first instance and others since 2005. because of the intercession of a former judge from the Sofia City Court. Loss over 800 million euros. The inaction of prosecutors and personally informed prosecutor general Sotir Tsatsarov about the grievances in Sofia Grass Court, Court of Appeal Sofia, Supreme Court of Cassation - violation of the law by judges, not fulfilled the enacons of judges, misplaced by the judges' laws, the bank of judges of banks, insurers - of all laws of mandatory judges' Directives of the European Union of Judges of the Sofia Court of Appeal - Kuzkoka, St. Mihaylov and ten doctors. Non-compliant mandatory directive for 2005 road accident victims the European Union and the Commission - damages of over 17 million euros. Judges from the Sofia Court of Appeal, such as Asya Sabeva, Daniela Doncheva, Kutzkova, Elizabet Petrova, Boyikov, Ivanov, Kemanov and dozens of others who gave their case on the actions of a physical person MD and companies represented by him in the Sofia City Court, instead of going away confirm the termination of the cases. Losses for over 900 million euros.

10.11. Failure to act by prosecutors in the Sofia city prosecutor office for clearly proven crimes - an order of companies with property that was previously forbidden by the court as collateral for claims over EUR 350,000 - applies two further to the guiding claim. The actions of Judge Raina Martinova of the Sofia City Court secured these losses. Inactivity also from the new main – prosecutor Ivan Geshev. And hundreds of other such evidence. Loses of 350 000 Euros.

10.12. The inaction of prosecutors of the Prosecutor General Sotir Tsatsarov and the new main since 2019 prosecutor Ivan eshev from the embezzlement of money from a construction company in a particularly large scale - yet the prosecutor Kyvulieva of the Sofia Regional Prosecutor's Office has delayed the file to put an end to it, losing more than 350,000 euros.

10.13. Inaction of Prosecutor General of the Prosecutor General Sotir Tsatsarov from the appropriation of money from a person Radoslav Payn who sells US passports and US driving licenses as evidence of his own and no cent in the US. Lose over 800,000 euros. There is actually a sale of Amerika's Pests to unconfirmed individuals - surely and among them jihadists. The security of Europe is endangered. Neither the Prosecutor's Office nor the State Agency for NSA, nor the Prime Minister Boyko Borissov personally take measures - obviously interested.

10.14. Failure to act by a prosecutor of the guilty prosecutor Sotir Tsatsarov for a racketeering carried out by the NRA and NRA servants seeking for individuals unpaid "Loan Taxes for 2 000 000 EUR, 6 000 000 your Budget, 8 000 000 EUR, with the ultimate goal to you help ownership. Ultimately, these individuals do not owe any state to the state. Lose for \$ 5 billion USD.

10.15. The inaction of prosecutors of the Prosecutor general Sotir Tsatsarov for proven frauds by the companies accounting for heat energy for the subscribers of "Toplofikacia Sofia" JSC. in Sophia for frauds an annual theft of over 160 million euros per year. Provided that the municipal company "Toplofikacia Sofia" EAD, which is managed by GERB people issues 450 000 invoices per year, provided that it has to issue 450 000 invoices per month - LOSS - ie. Stainless Steps million Euro of years from the subscribers of the citizens of the capital Sofia.

10.16. The inaction of the Prosecutor general Sotir Tsatsarov, despite the fact that Minister Liliana Pavlova, quite close to the Prime Minister Boyko Borisov, has allowed the sale of property of a state-owned company at prices of 2 to 5 times below the tax assessment of these properties - Mafia Neighbors.

10.17. The prosecutors conceal crimes of judges from Sofia City Court, judges from the Sofia Appeal Court, judges of the Supreme Cash Court and judges of the Supreme Administrative Court such as:

Sofia city Judge Vladimir Valkov whether he has hundreds of appeals against the actions of an individual and his companies only determined cases that have been won by the first installer does not deliver for the person and the companies to provide - a loss of more than 580 million euros. Judge Vladimir Valkov, who has given his objections to hundreds of times deliberately, termines deals against companies of the GERB MAFIA with damages of more than 460 million euros.

Judge Albena Boteva, Judge Raina Martinova, Judge Alexander Angelov, against whom there are lawsuits brought against them at the Sofia City Court, deliberately do not object if the conditions of Art. 22 of the Civil Proceedings Code because they have orders from Mafia that these companies and individuals lose their affairs. The judges of Sofia Court of Appeal - Doncheva, Kutkova, Elisete Petrova, Haidoukova, Kemanov, Boikinov, Assya Sabeva and dozens of others - almost 80% of the composition of the Sofia Appellate Court, having given their case to the Sofia City Court when they were judges of the Sofia City Court in the case of natural persons and their companies, termination of cases for billion USD from the Supreme Cassation Court. The judges of the Supreme Court of Cassation.

Former Deputy Chairman of the Supreme Court of Cassation Krasimir Vlachov, which has proved breaching the law and rules for caseous selection of judges and in specific claims, signed provided these personally appreciates, without this happening according to determined jurisdictions from the Supreme Court of Cassation to terminate the respective cases of individuals and companies - loss above 2 million EURO. For example, cases 1252/14, 1253/14 and 1254/14 - distributed to same judges, judges Ljubka Parvanova, Justinianova and Dimitrova - the case principle - mafia adjustment lost 120 million euros in this case. Judges of the Sofia Grand Court, the Sofia Court of Appeal, the Supreme Court of Cassation, confirmed the property of over EUR 500 million, the heirs of the former before 1945, the property of over 500 million Euros, confirmed by the State Agency for Security of Foreclosures of the former Soviet Union. insurance companies in Bulgaria. Loses more than 1 billion euros.

10.18. Lost complainss during the Sofia City Prosecutor Nikolay Kokinov and his deputy Roman Vassilev for a prize victory by the ministers Petar Dimitrov and dozens of others - losses for over 150 million Euros. No action by the Prosecutor general Sotir Tsatsarov.

10.19. Proven theft of a company through the suprenem cassition judges Hitrov and dozens of prosecutors of a whole factory "Record" AD Gorna Oryahovitsa for zero cents from MAFIA. Lose over 35 million euros.

10.20. Preparation of illegal act of notary deeds from Bourgas benefit of Anastas Anastasov - theft of real estates through the courts of the Supreme Court of Cassation, Bourgas District Court and Bourgas District Court for zero sotinki. Loss of more than 250,000 euros. The lawlessness of Simeon Mihov, Handjiev, Dilyana Yordanova, Zlatina Ivanova, Romyana Mankova from the courts in Burgas in favor of the theft - was lost for over 250,000 euros.

10.21. Bringing charges against innocent citizens for harassment and ruin- prosecutor officer Kostadinova of the Sofia Regional Prosecutor's Office raises a conviction of a person who has not committed a crime, and she is assisted by police officers Ivo Savov, Vandova, falsified experts from the Interior Ministry Damyan Georgiev. The person is justified because he is innocent.

- Prosecutor Stankova raises an accusation against the private enforcement agent, puts her in custody for 24 hours in prison, provided that the PEA has returned property to his own, which property is illegally used by a cop for more than 25 years. The Court of Justice in Sofia City Court apologizes to the private enforcement agent - a jail judge. Loss of health, reproductive features and more.

- Prosecutor Stankova raises accused after real fraud in prosecutor's office file.

- Prosecutor Daniela Dimitrova and prosecutor Yaneva raise charges on the grounds expressions of expressions That violate the laws and regulations of this state, raises accusations of fictions and fraud - in order of main protocols Sotir Castarov and Mafia.

- Prosecutor Slyvanova raises an accusation of an honest man - at the final account the judges of the action court Sofia and the Supreme Court of Cassation - become and apologize to the injured person. The person is justified because he is innocent.

- Prosecutor of SGP Popkolev, Dochev, others threw an umbrella over the criminal Mafia PEAs have damaged the state budget by more than 18 million euros, straining an umbrella over private companies and their owners in property theft of a state-owned company. - for tens of millions of euros. Orders by the prosecution to ruin citizens and families.

11. Principles of the Prosecutor's Office as Mafia Structure in the Mafia in Bulgaria protected from the USA and all the state structure and institutions of USA

The purpose of the prosecution in mafia-style is to crack down on citizens and companies that do not obey the executive - the Prime Minister and his racketeering and extortion for the transfer of property to companies. Making indictments with fake accusations or accusations of fraud and fraudulent expertise in violation of the laws of that country.

And vice versa:

Cloaking crimes committed by the prime minister, ministers, officials of the executive, representatives of state-owned companies.

Cloaking crimes committed by the Prime Minister, ministers who support the theft of state property on state-owned properties and damaging the state budget by millions of euros.

Closure of inactions and non-compliance with laws, failure to execute court decisions by the executive, the prime minister, ministers, mayors close to the ruling party.

Cloaking of crime - stealing state property, stealing private land, stealing land in favor of construction. Concealment of offenses by the executive - stealing EU funds. Cloaking schemes for theft and extortion of citizens from state-owned companies - supplying electricity, gas, heat, water.

Stretching an umbrella over executed crimes by prime minister, ministers, people of the executive.

Stretching an umbrella over mafia faces and loved ones to steal property for hundreds of millions of euros.

Stretching an umbrella over notary dealers who have drafted notarial deeds that have been stealing property for hundreds of millions of euros.

Stretching an umbrella over judiciary judges who commit crimes that rule acts in favor of the executive and the government and harass companies and citizens.

Stretching an umbrella over prosecutors who commit crimes, cloaking crimes of judges.

Stretching an umbrella by specialized prosecutors over judges who can not prove their millions where they are.

Stretching an umbrella by specialized prosecutors over ministers and prime minister that allow state budget bailouts from private bailiffs who are damaging the budget budget by tens of millions of euros.

Stretching the umbrella to the umbrellas and citizens who commit theft and fraud, but who are close to power, to the prime minister, to ministers.

As an example, the Chief Prosecutor of the Republic of Bulgaria Sotir Tsatsarov was elected on the basis of the election of Prime Minister Boyko Borisov, with the support of the United States and the CIA.

From 2013 Chief Prosecutor Sotir Tzatsarov has ratified the plan for racketeering, coercion, extortion of citizens and companies, hiding crimes committed by judges, prosecutors, prime ministers.

For all these actions of the Prosecutor's Office and personally the Chief Prosecutor Sotir Tsatsarov was notified the European Commission, the European Union, the European MEPs and USA - almost all, for the financing of EU funds and EU funds. The waste - no reaction.

Ergo - The European Commission, with President Juncker and the European Parliament and the European Commission, supports the Mafia in Bulgaria and the Mafia actions of European statesmen, the Chief Prosecutor, prosecutors, judges, ministers.

USA supports the mafia in Bulgaria, which operates at a state level that does not comply with mandatory directives. of the European Commission and the European Union.

USA supports the mafia in Bulgaria in a court and prosecutor's office who commit outrage, racketeering, coercion, extortion of companies and citizens who do not belong to the mafia of the ruling party with Prime Minister Boyko Borisov.

Specialized Prosecutor's Office established by the Government of Boyko Borisov is used for:

- repression against the inconvenient opponents of Boyko Borisov and the mafia.
- conceal and legalize crimes committed by judges and prosecutors in favor of the mafia-
- concealment of crimes committed by ministers, prime ministers
- concealment of crimes committed by judges and prosecutors

The purpose of the prosecutor's office for mafia:

Purpose - repression of citizens and companies that do not obey the executive power - the prime minister and his racketeering and extortion for the transfer of real estate to businesses.

The fabrication of criminal convictions with fabricated charges, or the charge of fraudulent charges and false examinations made in violation of the laws of that country.

And vice versa:

Concealment of crimes committed by the Prime Minister, by ministers, by officials of the executive power, of state structures, organizations, institutions.

Concealment of inaction and non-compliance with laws, non-enforcement of judgments by judges, prosecutors concerning crimes committed by ministers, prime ministers, officials of state institutions, ministries.

Crime concealment - theft of state property, theft of private land, theft of land in favor of construction.

Crime concealment of the executive - stealing EU funds.

Concealment of schemes for theft and extortion of citizens from state-owned companies - offering the supply of electricity, gas, heat, water.

12. Procedures, Schemes of Judges who Serve the Mafia in Bulgaria Protected from the US and all state structures and institutions of the USA

1. Distribution of not precisely defined cases to precisely designated judges who serve the Mafia for racketeering, losing cases, coercion.
2. Legalization through judges and their court acts of property theft, factories in favor of the mafia such as judges Vladimir Valkov, Yordanova, Boycheva by the Sofia City Court. Confirmation of this legalization at all subsequent instances.
3. Legalization through the judges and their court acts of the theft of property by the Metropolitan Municipality with the mayor Fandakova of the GERB Party of Boyko Borisov, private property for the purpose of selling the properties to the companies of the Mafia.
4. Legalization of theft of property by Mafia people such as Emil Kyulev acquired property in downtown Sofia for more than 900 million euros through the issuance of notarized acts and by crime notarial acts by notary Rumen Dimitrov - clearly and proven crimes.
5. Disappearance of cases in the courts against companies, mafia banks for stolen money for tens of millions of US dollars.
6. Disappearance of private property cases, example Sofia District Court, Sofia City Court.
7. Disappearance of property cases for EUR 900 million, real property of private individuals, property stolen by Emil Kyulev.
8. Disappearance of lawsuits filed against Mafia banking institutions as a case against UniCredit Bulbank for \$ 340 million, proceedings against other banks.
9. Disappearance of cases filed against the Sofia Municipality - a mafia bastion for hundreds of millions of levs.
10. Disappearance of cases brought against Mafia insurance companies.
11. Termination of cases in any manner unlawful and unlawful by fraud judges committed by judges in billion and euro real estate cases.
12. Dismissal of cases in every way with insane grounds and with real fraud by mafia Judges.
13. Decide and condemn people and businesses that are against this mafia.
14. Legalization of theft of property, companies, factories, assets, equipment through judges and prosecutors, through notaries.
15. Property theft through judges who legalize illegal notarial acts - proven fraud, through judges from the Sofia City Court Vulkov, Yordanova, Boycheva, Burgas - judges from Burgas District Court, District Court, Supreme Court of Cassation against money laundering, legalization decision of judges of the Sofia Court of Appeal - who do not respect enforced judgments, which do not respect or even mention indisputable evidence of real property.
16. Judges legitimize crimes committed by a decision of the Council of Ministers with Prime Minister Boyko Borisov, and cover up crimes committed by ministers and ministries, public services, the Sofia Municipality.
17. Judges such as Vulkov, Angelov legalize theft of equipment, millions, theft of factories, entire courts such as judges of the Supreme Court of Cassation.
18. Prosecutors legitimize the theft of slot machines, the theft of property by Emil Kyulev - buildings for more than 900 million euros in downtown Sofia - private property, theft of property, theft of land, theft of money - misappropriation Georgi Saykov Dichev, theft appropriation of money Stoyan Yakimov. Prosecutors are legalizing crimes committed by mafia judges. Prosecutors cover overt and proven crimes against judges, legalize court decisions that legitimize property thefts, factories, property, equipment.
19. Property Theft Through Private Bailiffs Who Are Mafia People - Theft Of Property Through Private Bailiff Georgi Syikov Dichev, Theft Of Property Through Private Bailiff Dachev, Private Bailiff Stoyan Yakimov - Boyko Mafia People. Theft of state-owned companies' property through private enforcement

agents such as the state-owned General Directorate of Construction and Restoration. And all of these are legalized by judges who confirm the crimes committed by private enforcement agents.

20. Property theft through a district governor, through the disappearance of documents, theft of documents by real owners, the sale of these private properties to businesses and individuals of the mafia. The properties are mostly in the centers of the cities of the capital, etc., they make a mortgage of the property and receive a loan from the Bank, use this loan for 10 years, and actually become the real owners of the property at the expense of the real owners, or do not use the property for 10 years, suddenly they cost the building, they make the property - car parking, they create an architectural project, then they start building. And this is all legitimized by the judges.
21. Property theft through Mayor Sofiyanski and Sofia Municipality with Mayor Fandakova - close to Prime Minister Boyko Borisov and judges legitimize these crimes.
22. Theft of property by concession by the Council of Ministers on private property for the purpose of theft and greasy property liked by mafia people. And this is legalized by judges.
23. The judges cover up crimes committed by the Prime Minister, by ministers, by officials of the executive branch.
24. Judges disguise and inaction, law enforcement.
25. Use of court and court rulings for theft of properties, factories, for zero pennies and "gifting" to persons close to the authorities and criminal groups for zero pennies.
26. Judges terminate lawsuits filed against the executive, against the Council of Ministers, against ministers, against bank insurance companies, mafia companies.
27. Judges pass rulings covering crimes from decisions of the Council of Ministers, ministers, ministries, ruling rulings with a clear and proven fraud - it is written that the land is subject to theft for municipal, not private.
28. Judges also legalize the concealment of crimes - theft of state property, theft of private land, theft of land in favor of construction.
29. Judges also legalize the crime of the executive - theft of EU funds and others.
30. The judges cover up schemes for theft and extortion of citizens from state-owned companies - offering the supply of electricity, gas, heat, water.

13. Purpose of the Mafiotismus by US Representatives for Bulgaria

- Control of Bulgarian governments - not only through finances, but also by the cultivation of loyal government and state subjects - from universities, world institutions, clubs, lodges, foundations, and then to become presidents, prime ministers, ministers, heads of government important agencies.

Control of the security services, prosecutors, judges, ownership of the compromise.

- Whole country control. Through debt securities control of governments, countries.
- Money control, their circulation, movement, direction, direction.
- Policy control and policies implemented.
- Press control and policy control.
- Controlling and preventing the introduction of technology and controlling and preventing the production of technology and free energy for use by all people and peoples. Control of patents that contribute to the development of civilization, not to see the white light, to be forgotten, not to use. Control and prevention of the production of developments for the treatment of deadly diseases.
- Import and export of corruption in one country to destabilize it.
- Imports of terrorism.
- Export and import of mafia principles in one country.
- Debt economy, money control. Who controls money controls states, societies, nations, governments.
- Mastery of the masses, peoples, personalities.

- Personality control, with debit, credit cards, mobile phones, mobile applications - continuous control ..
- Civil Society Control through Foundations - NGOs to replace public opinion, fund them to control and manage society.
- Possession of not all state resources, use of resources from oil, gold, silver, uranium and their income.
- Management of the population through environmental pollution.
- Technology management, when to bring one technology to a realization, why not, hold on to another, disappear.
- Crisis Generation - Any, economic, monetary, social, refugee, conflict, war political crises. The financial crisis occurs most rapidly, the currency crisis emerges instantly, followed by economic crises, Part of the financial crisis, and one of them is the currency crisis. A financial crisis ensues. There are always economic crises.
- A member-controlled world currency.

Principles of Mafiotismus - the new type of state governance in private and personal interests:

The state is governed by the Prime Minister if the same state is a parliamentary republic that has put in place and directs each state institution - a ministry, a state agency, manages both the executive and the judiciary through appointments that are close to him, and manages the legislative power - the parliament. The people are a crowd according to mobbing. Principles of crowd control: suppressing the masses to be guided by petty passions. Creating problems for the "crowd" - the people through taxes, high prices, high interest rates on bank services, management of the free means of citizens from the middle class, thus, through trickery and hypocrisy, the greatest human virtues are suppressed - honesty and honesty, which, according to mafia, are vices,

The rule of law - where the law begins, where it ends.

Gentle law enforcement, liberal rights,

The right of the strong. It interferes and removes all existing arrangements and regulations

Mafia puts a hand on the laws, reconfigures the institutions, the necessary and useful is only for their purposes and aspirations.

Formula of the Mafiotismus

The most simple model of the mafia that describes the factors that affect the amount, type, and etc of the mafia is the following:

Mafiotismus = Personal Power / on the top of state institutions / state and etc. / + Influence + Connections / to personal, private companies + Interests / personal, private, corporative / + Order / Orders + Personal management of all state neaveus + Personal Control of all states niveaus Mafia structure / inside or outside / + Monopoly Riegths + laws / rules / practices / procedures + possibility of taking an alternative decision - obligation - responsibilities - morality / ethics + Personal management and personal control of distribution of public state monetary and other resource (including European funds and funds).
