4. Generation and Financing of Terrorism and after this Combating this Terrorism - the New Strategy for the Profit for the Representatives of the Financial Banking Resource Techlogical Mafia-driven Materialismus

4.1. The cause - and the follow-up - at the state level

Staged Theorism - September 11, 2001:

The Nuclear Truth on the Occasion of September 11, 2001, for the Proclamation of Terrorism and Combating Terrorism by the United States and FBI Representatives Mafia Materialism.

It was announced that the two towers were destroyed by kerosene, and building # 7 of diesel fuel, which was for emergency diesel generators.

On September 11, 2001, agents from the FB were wearing full chemical gas mask kits to protect against radioactive dust from radioactive vapor. Creating networks, informant systems, to provide information - all kinds.

Bringing apart terrorists, bringing disagreements, unbundling the cohesion of terrorist groups, recruiting, focusing on leaders.

Scheme of creating fear for the population, with which fear of justifying any action by states, organizations, any kind of financing, in organizing, waging war.

Threats of terrorist acts against the population, created fear of citizens, are used to:

- Financing of counter-terrorism actions
- Financing wars and conquering countries
- Financing of the military industrial complex,

- Financing the development of strategic assets - nuclear submarines, ballistic missiles, nuclear missiles and others.

The idea of a war on terror was born after 9/11, in order to justify any action by the US government to allocate huge budgets to finance the fight against terrorism. Terrorism provides for the psychological destabilization of society. Really finding one enemy and designating it as a psychologically terrorist creates fear, hatred, horror, panic that arises in the society, which on the other hand is the reason and the reason for the representatives of the financial banking technology mafia materialized materialism to prepare measures for combating this terrorism. - Investing in new weapons and more.

On the other hand, the start of the New War - The Fight Against Terrorism, right after the end of the study war, dates from the 1960s and 1970s, when the United States and other countries organized and prepared radical Islamic Islam, financed it, so that it could a war was declared against him. In fact, the assassinations are justification for the ruling and representatives of the FBIHM for waging war, conquering states, subjugation of peoples. The cause is being used by the United States to adopt the Patriot Act - a Patriot Act - approved by the US House of Representatives and Congress by 357 to 66 votes. On November 26, 2001, George Walker Bush signed the law, which was extended until 2015 and who proclaims:

- Constitutional exercise of power over citizens
- The FBI is conducting erectile spying in violation of the Fourth Amendment to the Constitution.

The attacks serve as justification for wars, subjugation of states, eavesdropping, harassment, questioning the civil and constitutional rights of citizens in a democratic society. The beginning of preparation for this fight against terrorism began as early as the 1980s, when the West and the United States supported, created Islamic integrism, with the ultimate goal of counteracting the occupation of the USSR in Afghanistan.

4.2. The Afghanistan War

The Afghan war is called the "culture war", or the "crusades" against the Islamized world by the organizers of the fight are terrorism. The war with Afghanistan began on 7 October 2001. It is a military operation of a coalition of US-led states aimed at controlling the entire country of Afghanistan. The operation is called Operation Triple Freedom. It starts with 28,300 US servicemen. The second operation is NATO - ISAF, with the participation of the United Kingdom, Canada, Australia. In these operations, US and British planes have been bombing entire cities for weeks. In early 2002, the land operation began.

The reason for starting the war is the demand for Osama Bill Laden's extradition requested by the Afghan government. After the Afghan government refused, it was given a carte blanche to start the war, the other goal being the overthrow of the Islamic regime by the Taliban. On May 2, 2011, US commandos killed Osama bin Laden. The actual cost of this war is \$ 1 trillion, with the Department of Defense, the State Department and the Agency for International Development claiming to have spent between \$ 934- \$ 978 billion. The money is actually spent uncontrollably, one billion is given to helicopters and airplanes to arm the Afghan state, which have not been used for a long time, a billion are given to construct buildings and infrastructure, \$ 34 million to grow soybeans, which in reality but can to plow through the lands of Afghanistan, \$ 28 million for special camouflage uniforms, provided that only 2.1% of Afghanistan's area is forested. In fact, 775,000 US troops have participated in the war in Afghanistan.

All this is true that the governments of George W. Bush, Barack Obama and Donald Trump have not told the truth about the goals for the war in Afghanistan and the real money spent is not true, proves a December 12, 2019 Washington Post post. 2000 pages of confidential documents proving that the purpose was not to establish a democratic government in Afghanistan, none of the above is true.

The fact that all the spending of money is for the ultimate purpose of securing profit for the representatives of the Financial Bank Resource Technological Mafia Materialism is also proved by the fact that for 2015. The Pentagon has spent an estimated \$ 6.5 trillion, such reports have existed since 1998. ie expenses for the period 1998 - 2015 are at least \$ 21 trillion. This is real money printed, which is the ultimate goal of earning the representatives of the financial bank resource technology mafia materialism.

4.3. The War in Iraq and What the Figures are - the Profits

The Iraq war gives an investment of \$ 411 million every day. In reality, the cost of the Iraq war is between \$ 3 trillion and \$ 4.4 trillion. The war began on March 20, 2003 when Britain and the United States attacked by air, land and sea, backed by Australia, Denmark, Poland, Spain. On March 6, 2003, the inspectors published a report declaring that they did not believe that Iraq - with its steady economy and development level - was able to develop or maintain a program for the development of weapons of mass destruction.

On the other hand, the US has repeatedly stated that the al-Qaeda group has terrorist training camps in Iraq and that Saddam Hussein himself supports it financially. Al-Qaeda's relative, Osama bin Laden, strongly denies this. Apart from that, it is stated that Iraq produces chemical and bacteriological weapons, which they could not find even after the state was destroyed and invaded and conquered.

Every second of the Iraq war costs \$ 5,000. In 2001. George W. Bush comes to power. This year, the financial sector becomes more powerful, more profitable and more concentrated. Five investment banks, two financial conglomerates, three rating agencies and three insurance companies are leading. A trillion dollar business is being set up.

The war in Iraq is worth \$ 5,000 for every second.411 million every day.

The current cost per month is \$ 12.5 billion.

The cost is up to 25 billion a month. The estimated price will be \$ 3 trillion.

The cost of the war is 3.7 - 4.4 trillion dollars in 10 years.

The Price of War - The Watson Institute for International Studies at Brown University.

The cost of war is financed by the accumulation of deficits - which must include interest. In addition, the Pentagon received an additional \$ 326 billion and \$ 652 billion beyond the direct funding for the military. Homeland security has spent \$ 401 billion.

In addition, the military who fought in Iraq and Afghanistan have filed additional claims for \$ 32.6 billion and for disability and treatment.

Veterans' compensation costs will increase from \$ 598 to \$ 934 billion.

Costs range from \$ 2.9 trillion to \$ 3.6 trillion.

George W. Bush - Congress allocates an additional \$ 120 billion

The war with Iraq began on March 20, 2003 when the United States and Britain attacked by air, land and sea. Supported by Australia, Denmark, Poland and Iceland.

Without a declaration by the UN Security Council to legitimize the invasion.

4.4. The creation of Al - Qaeda by the CIA and the United States and the subsequent war with al - Qaeda

Al-Qaeda was created in 1988 and is made up of mostly Mujahideen fighting the Soviet invasion by veterans of the 1979-1989 war against the Soviet Union. In fact, bin Laden is funded for this activity by the United States - the CIA, according to unofficial data, the CIA has allocated about \$ 500 million annually for the preparation and military assistance of the Mujahideen.

A US-backed slam rescue fund was later set up to strengthen Sunni extremism on an anti-conscientious basis. The goal is to counter Shi'ite Iran, which is the main enemy of the United States. The goals of Al - Qaeda and the US are the same - the expulsion of the USSR from Afghanistan. After the end of the war, bin Laden redirected his actions against infidels in every other country. 1998 bin Laden establishes the Islamic International Front for Combating Jews and Crusaders in Afghanistan, after being denied citizenship in Sudan. The headquarters of the organization 1991, when it was established, are located in Afghanistan and Pakistan. From 1991 to 1996 the headquarters is in Sudan - Khartoum. After the fall of 2003, al-Qaeda moved from Afghanistan to Iraq and Iran. The organization is primarily funded by companies controlled by Bin Laden in 35 countries. The status of bin Laden himself is estimated at about \$ 300 million. The largest economic entities are Wadi Av Akiz, Laden International, US \$ 300 million total capital, Taba Investment, Hijra Construction, Al Shamal Islamic Bank.

4.5. The creation and financing of an Islamic State by the United States and US partners and the war

The group's brain is Samir Abdel Muhammad al-Khalifawi (former Haji Bakar) - former colonel of Saddam Hussein Air Force Defense Intelligence. He created one of the predecessors of ISIL - Islamic State in Iraq. He also appointed Abu Bakr al-Baghdadi in 2010 as ISIL leader. He also plans to deploy the group in Syria. 2014 was killed by Syrian rebels.

It navigates the organization's plan, organizational charts, lists, programs, structure, action directives, operational program. Hadji Bakker makes the structure of Islamic State at the local level, ways and procedures of penetration into villages, way of monitoring, plan of attack, technical plan for Islamic State intelligence management, makes a plan for the study of worshiped people in the area, sources of their income, a list of the names of the members of the brigades, the names of the leaders of those brigades, the investigation of their illegal activities for the purpose of blackmailing and harassment, and extortion for the purpose of carrying out the government's procurement activities.

Creating a scheme of informants, ex-scouts dissatisfied with the system, Plans include schools, kindergartens, media, transportation, finance, monitoring systems at all levels, to ensure monitoring at any and all levels. In 2010, Saddam Hussein's Iraqi recruiting services were appointed to the emir, later by Caliph Abu Bakr al-Baghdadi.

The Islamic State is governed by one leader and four Shariah councils, a religious council, a Shura-advisory council, a military council and a security council. Islamic states are opening missionary offices through which the organization expands in secret, without noise, and very comprehensively. Enlargement takes place without resistance, without attention, and at the same time abductions and killings of enemies of the state take place. Military camps have been set up in many places since late 2012, and newcomers have been training for two months. The organization is inconspicuous and is expanding at a tremendous pace. In the fall of 2013, ISIL counted 2,650 foreign fighters. The organization simulates multiplicity, with its fighters appearing in black masks and, when they appear in many places, simulating multiplicity. Persons who may be a potential leader or foe are removed.

The main features of ISIL are:

- Organization of a rebel type
- An uncompromising jihadist-Salafist organization
- Extreme terrorist methods and rebel strategy are used
